**RESOLUTION INTERPOSING NO OBJECTION AND THEREBY AUTHORIZING SHOWYA TELECOM SERVICES CORP./ZTE PHILIPPINES CORP./DITO TELECOMMUNITY INC. FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE AND OPERATION OF COMMUNICATION CELLSITE TOWER AT SAGKAHAN, BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY.**

**WHEREAS**, the Showya Telecom Services Corp. has been commissioned by ZTE Philippines Corp. for the DITO Telecommunity Inc., a 3<sup>rd</sup> Telco Player, and thereby tasked to identify, negotiate and install additional telecommunication services;

**WHEREAS**, the project is in line with the company's ongoing commitment to provide world class telecommunication services in the City of Sorsogon;

**WHEREAS**, the cell site shall be constructed and installed at Sitio Sagkahan, Barangay Abuyog, East District, Sorsogon City at the land owned and registered in the name of Mrs. Helen L. Jamisola;

**WHEREAS**, the Showya Telecom Services Corp. shall be liable in case of any untoward incidents of any form and kind, during the construction and installation of the cellsite;

**WHEREAS**, the ZTE Philippines Corp. and the DITO Telecommunity Inc. shall be jointly liable in case of any untoward incidents of any form and kind for the maintenance and operation of the cellsite,

Ravanilla**, resolved as it is hereby resolve to interpose no objection and thereby authorizing Showya Telecom Services Corp./ZTE Philippines Corp./DITO Telecommunity Inc. for the construction, installation, maintenance and operation of communication cellsite tower at Sitio Sagkahan, Barangay Abuyog, East District, Sorsogon City.
