RESOLUTION INTERPOSING NO OBJECTION ON THE CONDUCT OF REHABILITATION OF SMART UNDER GROUND FACILITIES DUE TO MULTIPLE FOC BREAK OF SMART SORSOGON B21 BTS TO GUINLAJON BTS BY AD TECH CONSTRUCTION AND INDUSTRIAL SERVICES CORPORATION COVERING PORTIONS OF BARANGAY GUINLAJON, PANGPANG AND MACABOG, ALL OF WEST DISTRICT.

WHEREAS, on June 10, 2020, Engr. Neil L. Aguila, Project Manager, AD TECH Construction and Industrial Services, assigned contractor of PLDT, wrote a letter addressed to the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City respectfully requesting for a Work permit for the aforementioned endeavour with the hereunder scope of works;

1. Cutting of pavement;
2. Breaking and restoration;
3. Horizontal Directional Drilling;

4. Manhole installation;
5. Pipe Laying; and
6. Cable Laying

WHEREAS, AD TECH Construction and Industrial Services Corporation was among the corporations duly endorsed by the Local Chief Executive as mentioned through her letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and Members of the 7th City Council dated June 18, 2020 and the same was officially referred jointly to the Committee on Public Utilities, Committee on Land use and the Committee on Infrastructure;

WHEREAS, series of committee hearings were conducted inviting the presence of concerned parties and relevant documents submitted by the applicants were assessed and among those who immediately complied with necessary documents as required by the Sangguniang Panlungsod is AD TECH Construction and Industrial Services;

WHEREAS, upon assessment and compliance of the documents required by the aforementioned requesting party to the Sangguniang Panlungsod, the 7th City Council deemed it necessary to pass a resolution interposing no objection on the conduct of rehabilitation of Smart Under Ground Facilities due to Multiple FOC Break of Smart Sorsogon B21 BTS to Guinlajon BTS by AD TECH Construction and Industrial Services Corporation covering portions of Barangay Guinlajon, Pangpang and Macabog, all of West District;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Joven G. Laura**, resolve as it is hereby resolved to interpose no objection on the conduct of rehabilitation of Smart Under Ground Facilities due to Multiple FOC Break of Smart Sorsogon B21 BTS to Guinlajon BTS by AD TECH Construction and Industrial Services Corporation covering portions of Barangay Guinlajon, Pangpang and Macabog, all of West District;

RESOLVED FURTHER, that the resolution interposing no objection issued by the Sangguniang Panlungsod shall cover only the aforementioned scope of works and immediate restoration of the same shall be for the account of the contractor;

RESOLVED FINALLY, that copies of this resolution shall be furnished to the requesting party and the same shall be an integral part of their Work Permit.
