RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A DEED OF CONDITIONAL DONATION FOR A FOUR HUNDRED (400) SQUARE METER PORTION OF THE TWO (2) HECTARE LOT UNDER TAX DECLARATION NO. 2011-01-0013-00980 WITH THE BUREAU OF FIRE PROTECTION REPRESENTED BY SINSP. ERIC A. CARAMOAN INTENDED FOR THE CONSTRUCTION OF THE LATTER'S OFFICE AT BACON DISTRICT, SORSOGON CITY.

WHEREAS, on July 07, 2020, the 7<sup>th</sup> Regular Session of the City Council, the august body discussed the letter request of the Local Chief Executive respectfully requesting for the passage of a resolution authorizing the City Mayor to enter into an Amended Memorandum of Agreement in relation to the previous resolution passed an approved by the City Council under Resolution No. 082, series of 2020 dated September 03, 2020 entitled "Resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to execute a Deed of Conditional Donation for a Four Hundred (400) square meter

portion of Lot 1 situated at Barangay Poblacion, Bacon District, Sorsogon City duly covered by Tax Declaration No. 2011-01-0013-001372 in favour of the Bureau of Fire Protection, Sorsogon as represented by the Acting City Fire Marshall, SINSP Eric A. Caramoan;

**WHEREAS**, aforementioned letter request was officially referred to the Committee on Peace, Public Order and Safety and on July 07, 2020 a Committee Hearing was called for the purpose;

**WHEREAS**, as appearing and contained in the approved Committee Report No. 060, series of 2020 rendered by the Committee on Peace, Public Order and Safety presented during the July 28, 2020 regular session, the supposed area as previously mentioned as contained in Resolution No. 082, series of 2020, was identified as service road during the repair of the Old Municipal Building;

**WHEREAS**, with the presence of representatives from Bureau of Fire Protection, a new area was identified described as a Four Hundred Square Meter Lot being a portion of Two Hectares Agricultural Land under Tax Declaration No. 2011-01-0013-00980 declared in the name of Municipality of Sorsogon;

**WHEREAS**, let it be stated for the record also that upon tedious verification, no Deed of Conditional Donation in relation hereof was previously entered into by parties herein mentioned, thus Amended Conditional Deed of Donation would not be necessary;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Deed of Conditional donation for a four hundred (400) square meter portion of the two (2) hectares lot under Tax Declaration No. 2011-01-0013-00980 with the Bureau of Fire Protection represented by SINSP. Eric A. Caramoan intended for the construction of the latter's office at Bacon District, Sorsogon City;

**NOW THEREFORE**, on motion of **City Councilor Nestor J. Baldon** duly seconded by **City Councilor Franco Eric O. Ravanilla**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Deed of Conditional donation for a four hundred (400) square meter portion of the two (2) hectares lot under Tax Declaration No. 2011-01-0013-00980 with the Bureau of Fire Protection represented by SINSP. Eric A. Caramoan intended for the construction of the latter's office at Bacon District, Sorsogon City;

**RESOLVED FURTHER**, that the Deed of Conditional Donation entered into by parties herein mentioned shall be an integral part of this resolution;
