## Resolution No. 193, Series of 2019

RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF TWO (2) STAG DERBY (FINAL ROUND) AT THE SORSOGON CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the September 24, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Mr. Sony Diaz, Representative, Oragon GameFowl Breeder's Alliance (OGBA) dated September 19, 2019 addressed to City Councilor Nestor J. Baldon, Chairman, Committee on Games and Amusement requesting for the conduct of Two (2) Stag Derby Final Round at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City on January 11, 18, 22 and 25, 2020;

WHEREAS, as reflected in the request, it is stated that portion of the proceeds will be donated to charitable institutions;

WHEREAS, as per consensus during the October 4, 2019 committee hearing, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to identified charitable institutions in the City of Sorsogon and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the city;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution approving and authorizing the conduct of Two (2) Stag Derby Final Round at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**NOW THEREFORE,** on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolve as it is hereby resolved to **approve and authorize the conduct of Two (2) Stag Derby Final Round at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City;** 

**RESOLVED FURTHER**, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;
