**WHEREAS**, on October 10, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to accept the medical equipment from the Department of Health (DOH) under the Health Facilities Enhancement Program;
