RESOLUTION DISMISSING THE ADMINISTRATIVE CASE FILED BEFORE THE SANGGUNIANG PANLUNGSOD BY COMPLAINANT MRS. CRISANTA DEBLOIS BUEN AGAINST RESPONDENT BARANGAY KAGAWAD FERDINAND BONOS OF BARANGAY CAMBULAGA, WEST DISTRICT, SORSOGON CITY PURSUANT TO THE LETTER OF ATTY. CHRISTIAN R. SANTONIA, PUBLIC ATTORNEY II DATED JULY 22, 2020 ADDRESSED TO HON. MA. THERESA PERDIGON, LIGA PRESIDENT, SORSOGON CITY.

WHEREAS, pursuant to relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991, administrative cases against erring elective barangay officials shall be filed before the Sangguniang Panlungsod;

WHEREAS, aforementioned complainant filed an administrative case before the Sangguniang Panlungsod against Barangay Kagawad Bonos of Barangay Cambulaga and the same was referred to the Committee on Barangay affairs;

WHEREAS, a Committee Hearing was previously conducted for the purpose with the intent for a possible conciliation by and between parties herein mentioned but to no avail, however, complainant requested that she be given ample time to think about the matter;

WHEREAS, on July 22, 2020, Atty. Christian R. Santonia, Public Attorney II wrote a letter addressed to Hon. Ma. Teresa D. Perdigon, Liga President wherein complainant for herein mentioned administrative case through the Public Attorney's Office signifying her intent to withdraw the Administrative case filed against herein respondent without prejudice to the other remedies that maybe available to her;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City council deemed it necessary to pass a resolution dismissing the Administrative Case filed before the Sangguniang Panlungsod by complainant Mrs. Crisanta Deblois Buen, against Respondent Barangay Kagawad Ferdinand Bonos of Barangay Cambulaga, West District, Sorsogon City pursuant to the Letter of Atty. Christian R. Santonia, Public Attorney II dated July 22, 2020 addressed to Hon. Ma. Theresa Perdigon, Liga President, Sorsogon City;
