RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH CASA MIANI (SOMASCAN FATHERS) FOUNDATION, INCORPORATED RELATIVE TO THE GRANT OF FINANCIAL SUBSIDY

WHEREAS, on October 14, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary respectfully requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with Casa Miani (Somascan Fathers) Foundation, Incorporated relative to the grant of financial subsidy;

**WHEREAS**, Casa Miani is a non-profit and temporary residential care institution licensed and accredited by the Department of Social Welfare and Development (DSWD)

which currently caters to more than fifty (50) children who are orphaned, abandoned, neglected, school drop-outs and in high risk situations without physical and psychological handicaps;

**WHEREAS**, for the past years, the City Government of Sorsogon has been supporting the needs of the children especially in the aspect of their education;

**WHEREAS,** last August 2019 the previous contract/MOA for subsidy lapsed thereby the need for its renewal;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 6<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with Casa Miani (Somascan Fathers) Foundation, Incorporated relative to the grant of financial subsidy;

NOW THEREFORE, on motion of Hon. Fernando David H. Duran, III, duly seconded by Hon. Joven G. Laura, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, to enter into a Memorandum of Agreement (MOA) with Casa Miani (Somascan Fathers) Foundation, Incorporated relative to the grant of financial subsidy;

**RESOLVED FURTHER**, that the Memorandum of Agreement entered into by the parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Office of the Secretary to the Sangguniang Panlungsod for records and archive purposes;
