**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO CONDITIONALLY DONATE TO THE SORSOGON CITY POLICE STATION REPRESENTED BY PLT.COL. BENITO E. DIPAD, JR. THE PARCEL OF LAND WHEREIN A POLICE STATION IS SITUATED AT IMPERIAL RIDGEVIEW SUBDIVISION, PANGPANG, WEST DISTRICT, SORSOGON CITY.**

**WHEREAS**, on July 24, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, for a passage of a resolution authorizing the undersigned to conditionally donate to the Sorsogon City Police Station represented by Plt.Col. Benito E. Dipad, Jr. the parcel of land wherein a police station is situated at Imperial Ridgeview Subdivision, Pangpang, West District, Sorsogon City;

**WHEREAS**, aforementioned letter request has reference with the previously perfected donation from Imperial Homes Corporation in favor of the City Government of Sorsogon comprising of road lots, open spaces, community facilities and parks and playground of the Imperial Ridgeview Subdivision situated at Barangay Pangpang, West District, Sorsogon City;

**WHEREAS**, as per agreement with the donee, Police Community Precint 1 (PCP1) shall be transferred from the corner of Magsaysay St and Rizal Streets (near Chowking) to the donated portion of their property;

**WHEREAS**, since the Philippine National Police (PNP) shall be utilizing the said building, it is deemed necessary to conditionally donate the property on which their station is erected;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to conditionally donate to the Sorsogon City Police Station represented by Plt.Col. Benito E. Dipad, Jr. the parcel of land wherein a police station is situated at Imperial Ridgeview Subdivision, Pangpang, West District, Sorsogon City;

**NOW THEREFORE**, on motion of **City Councilor Nestor J. Baldon**, duly seconded by **City Councilor Rebecca D. Aquino**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to conditionally donate to the Sorsogon City Police Station represented by Plt.Col. Benito E. Dipad, Jr. the parcel of land wherein a police station is situated at Imperial Ridgeview Subdivision, Pangpang, West District, Sorsogon City;
