**RESOLUTION AUTHORIZING HON. CITY MAYOR MA. ESTER E. HAMOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR THE PREPARATION OF THE CONCEPTUAL PLAN, PROCUREMENT, SUPERVISION AND CONSTRUCTION MANAGEMENT OF ISOLATION FACILITY/OFF – SITE DORMITORY IN THE CITY OF SORSOGON**

**WHEREAS**, the city government is in need of a bigger quarantine facility in view of the increasing number of Locally Stranded Individuals (LSIs) and returning Overseas Filipino Workers (OFWs) to the city of Sorsogon;

**WHEREAS**, the city government, through the City health Office is now in the process of identifying a parcel of land within the city for the construction of an isolation facility, its management as well as the procurements of materials for the operation of the same;

**WHEREAS**, with the COVID 19 public health crisis, the city government requested the DPWH's assistance in constructing isolation facilities and/or providing shelters for their front liners and other healthcare workers through the "We heal as one offsite dormitory for medical personnel" to alleviate the daily operational challenges during the crisis;

**WHEREAS**, the funds for the proposed project will be considered out of the appropriation comprehensively released to the DPWH Central Office through the FY 2020 General Appropriation Act (GAA);

**WHEREAS**, the Department of Public Works and Highways (DPWH) shall undertake the preparation of the conceptual plan of the proposed isolation facility/off – site dormitory, procurement and the corresponding construction management and supervision of the project;

**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the *promotion of the general welfare*. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, *promote health and safety*, improve public morals, enhance economic prosperity and social justice, maintain peace and order and *preserve the comfort and convenience of their inhabitants*;

**NOW THEREFORE**, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to pass a resolution authorizing Hon. City Mayor Ma. Ester E. Hamor to enter into a Memorandum of Agreement (MOA) with the Department of Public Works and Highways (DPWH) for the preparation of the conceptual plan, procurement, supervision and construction management of isolation facility/off – site dormitory in the city of Sorsogon.
