RESOLUTION AUTHORIZING HON. CITY MAYOR MA. ESTER E. HAMOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ROMAN CATHOLIC BISHOP OF SORSOGON RELATIVE TO THE USE OF THE FIRST FLOOR OF THEIR BUILDING LOCATED AT BACON DISTRICT, SORSOGON CITY

WHEREAS, in anticipation with the impending repair of the Bacon Rural Health Unit at Poblacion, Bacon District, Sorsogon City, the city government is looking for a building which shall serve as a temporary edifice for the RHU;

**WHEREAS,** the city government had forwarded a letter to Bishop Jose Allan V. Dialogo requesting for the permission to utilize their building which was previously operating as a hospital for the aforesaid purpose;

WHEREAS, the Roman Catholic Bishop of Sorsogon had eventually acceded to the request of the city government and granted permission to use the first floor of the said building subject to the stipulation that may be agreed upon through a Memorandum of Agreement (MOA);

**WHEREAS**, the Roman Catholic Bishop of Sorsogon shall allow the city government to carry out its health services and the right to use the aforesaid building for a period of six (6) months commencing on August 1, 2020 until January 30, 2021;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the *promotion of the general welfare*. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, *promote health and safety*, improve public morals, enhance economic prosperity and social justice, maintain peace and order and *preserve the comfort and convenience of their inhabitants*;

NOW THEREFORE, on motion of Hon. Nestor J. Baldon, duly seconded by Hon. Joven G. Laura, resolved as it is hereby resolve to pass a resolution authorizing Hon. City Mayor Ma. Ester E. Hamor to enter into a Memorandum of Agreement (MOA) with the Roman Catholic Bishop of Sorsogon relative to the use of the first floor of their building located at Bacon District, Sorsogon City.
