## Resolution No. 200, Series of 2020

RESOLUTION ENCOURAGING BUSINESS ESTABLISHMENTS, PUBLIC AND PRIVATE OFFICES IN THE CITY OF SORSOGON TO PROVIDE BIKE RACKS IN THEIR RESPECTIVE PREMISES IN COORDINATION WITH THE CITY TRAFFIC MANAGEMENT EMERGENCY AND CIVIL SECURITY (TMECS)/SK3

**WHEREAS,** during the period of community quarantine that allows certain percentage for the operation of transport sector, bicycle became the most reliable mode of transportation to many;

WHEREAS, biking activity as a form of routine exercise provides multiple health rewards in improving human wellbeing not to mention its contribution in minimizing the presence of air pollution and its environmentally friendly impact to ecological balance;

WHEREAS, bicycle is a cheapest and easiest means of transportation;

WHEREAS, providing secured bicycle parking racks in business establishments and in private and public offices would encourage residents of Sorsogon City to utilize bicycle as one of the most convenient modes of transportation in the city;

WHEREAS, provisions of bike racks shall not be allowed along Magsaysay and Rizal Streets so as not to compromise the flow of traffic therein:

WHEREAS, business establishments along Magsaysay and Rizal Streets with designated parking areas, are most respectfully encouraged to provide bike racks for their customers:

WHEREAS, installation of bike racks in business establishments, public and private offices in the city of Sorsogon shall be with prior coordination with the City Traffic Management Emergency and Civil Security (TMECS)/SK3.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

NOW THEREFORE, on motion of Hon. Franco Eric O. Ravanilla, duly seconded by Hon. Nestor J. Baldon, resolved as it is hereby resolve to pass a resolution encouraging business establishments, public and private offices in the city of Sorsogon to provide bike racks in their respective premises in coordination with the City Traffic Management Emergency and Civil Security (TMECS)/SK3.
