RESOLUTION EARNESTLY REQUESTING ALL BANKING INSTITUTIONS WITH AUTOMATED TELLER MACHINES (ATMs) IN THE CITY OF SORSOGON TO PROVIDE THEIR RESPECTIVE CLIENTS A CUSTOMIZED PEDAL CONTROLLED DISINFECTANT DISPENSER IN ALL ITS ATM OUTLETS TO AVOID WIDESPREAD TRANSMISSION OF COVID 19

WHEREAS, it was observed that all ATM outlets of any banking institution in the city of Sorsogon cater their services on a daily basis without any sanitizer or alcohol to be used by their clients, thus, the possibility of widespread transmission of COVID 19 is highly probable;

WHEREAS, traditional and manual method/system in dispensing hand sanitizer or alcohol to its clients do not provide assurance of eliminating or avoiding community or widespread transmission of COVID 19, for there is still a direct contact between the

clients and employees of the establishment while using the same container of the sanitizer, thus, the same is not advisable for ATM outlets;
WHEREAS, customized pedal controlled disinfectant dispenser, usually for sanitizer and alcohol, could ensure no transmission of virus that could be passed from client to clients;

WHEREAS, pedal controlled disinfectant dispenser, being in a customized form or mechanics could be produced in a cheapest, prompt and easiest manner;

WHEREAS, introduction of customized pedal controlled disinfectant dispenser in all ATM outlets, as part of social corporate responsibility to combat COVID 19 and other similar health crisis, is also requested to be formed part of the so called “new normal”;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the *promotion of the general welfare*. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, *promote health and safety*, improve public morals, enhance economic prosperity and social justice, maintain peace and order and *preserve the comfort and convenience of their inhabitant*;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to pass a resolution earnestly requesting all banking institutions with Automated Teller Machines (ATMs) in the city of Sorsogon to provide their respective clients a customized pedal controlled disinfectant dispenser in all its ATM outlets to avoid widespread transmission of COVID 19.
