**RESOLUTION INTERPOSING NO OBJECTION FOR THE ROAD EXCAVATION OF A ROAD CANAL CONNECTION LOCATED AT DAGÑALAN STREET, BARANGAY SAMPALOC, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, On July 6, 2010 a letter-request from Architect Lorenzo Ray Tanael, UAP addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod requesting for road excavation intended for a road canal connection was among the items deliberated in the July 7, 2020 Regular Session of the 7<sup>th</sup> City Council;

**WHEREAS**, the request is in line with the on-going construction of a two-storey mixed-used building with deck located at Dagñalan Street, Barangay Sampaloc, East District, Sorsogon City owned by Mr. Mike Jester Volante;

**WHEREAS**, on July 30, 2020 a committee hearing was conducted for the purpose and therein obtained that the requesting party will comply all the needed requirements thereto thus to favorably endorse the passage of a resolution;

**WHEREAS**, it is the mandate for the local government unit to exercise the powers expressly granted, those necessarily implied there from, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution interposing no objection for the road excavation of a road canal connection located at Dagñalan Street, Barangay Sampaloc, East District, Sorsogon City;
