RESOLUTION RESPECTFULLY REQUESTING HON. CONGRESSWOMAN EVELINA "NANAY EVIE" ESCUDERO OF THE FIRST CONGRESSIONAL DISTRICT OF SORSOGON TO APPROPRIATE FUNDS INTENDED FOR THE CONSTRUCTION OF 600 METER FLOOD/RIVER CONTROL SYSTEM AT BARANGAY TICOL, WEST DISTRICT, SORSOGON CITY

WHEREAS, the Sangguniang Barangay of Ticol has passed Resolution No. 16, Series of 2019 which requested Hon. Congresswoman Evelina "Nanay Evie" Escudero of the First Congressional District of Sorsogon, for financial assistance for the construction of 600 meter flood/river control system at Barangay Ticol, West District, Sorsogon City;

WHEREAS, the more or less 600 meter river bank located in the said barangay is a long time vulnerable for erosion particularly during torrential rain and typhoons;

WHEREAS, the construction of the flood/river control system in the area will serve as a mitigating action or measure against climate change;

WHEREAS, the continues erosions on both sides of the river bank resulted to downsizing of the area, thus affecting 500 hectares of rice fields of 400 farmers who are dependent to it;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to respectfully request Hon. Congresswoman Evelina "Nanay Evie" Escudero of the First Congressional District of Sorsogon, to appropriate funds intended for the construction of 600 meter flood/river control system at Barangay Ticol, West District, Sorsogon City;
