RESOLUTION AUTHORIZING THE CITY PLANNING AND DEVELOPMENT OFFICE (CPDO) TO DISPLAY ALL CITY ORDINANCES **SANGGUNIANG APPORTIONED** RESERVED FOR THE **PORTAL** PANLUNGSOD IN THE OFFICIAL WEB SITE OF THE CITY GOVERNMENT **OF SORSOGON** 

WHEREAS, the measure aims to provide the general public a simple, convenient, and easy access to a ready reference of full text ordinances of the Sangguniang Panlungsod in its organized and orderly presentation;

WHEREAS, all ordinances shall be sorted out, compiled, arranged, divided, grouped, and categorized by and according to its subject, application or area of concern and shall be displayed in the apportioned portal reserved for the Sangguniang Panlungsod in the official web site of the city government of Sorsogon;

**WHEREAS,** all **ordinances shall be** sorted out, compiled, arranged, divided, grouped, and categorized into the following subjects/applications or areas of concern, to wit:

- 1) ENVIRONMENTAL PROTECTION AND CLIMATE CHANGE All ordinances relating to the conservation and protection of the environment in the City of Sorsogon, the regulation of the impact of human and business activities and all matters relative to environment-related issues;
- 2) **HEALTH AND SANITATION** ordinances related to health, sanitation and hygiene; regulations pertaining to the operation of health centers, medical hospitals and clinics, and all other health and sanitary measures;
- 3) **PUBLIC WORKS AND INFRASTRUCTURE** ordinances regulating the construction, maintenance, improvement and repair of public buildings, bridges, roads, parks, drainage, flood control and protection and other infrastructure projects and similar activities;
- **4) PUBLIC UTILITIES AND TRANSPORTATION** measures regulating the use, operation and maintenance of public utilities, public services, communication and transportation facilities;
- 5) **TRICYCLE FRANCHISE** ordinances pertaining to the issuance, renewal and all other related transactions relative to tricycle franchise;
- 6) PUBLIC ORDER AND SAFETY ordinances related to police matters, maintenance of peace and order, fire prevention and control measures, jail management and all matters pertaining to peace and order and public safety;
- 7) AGRICULTURE AND FOOD- pertains to ordinances related to agriculture, food production and agri-business; agricultural economic research and conservation; agricultural education and extension services; animal industry and livestock quarantine, farm credits, fisheries and aquatic resource preservation and development of fishing grounds, and construction of fish ponds, corrals, oyster beds, and all other similar regulatory measures thereof;
- 8) MARKET, TRADE, COMMERCE AND INDUSTRY ordinances relating to domestic or local trade, regulations for public and private market, standard weights and measures, handicrafts and cottage industries, consumer protection, control of prices of commodities, and matters relating to development of local economic enterprises;
- TOURISM INDUSTRY all ordinances related to promotion of tourism and the tourist industry and all matters relating to all investments in the City;
- 10) PERSONNEL AND ADMINISTRATION ordinances pertaining to the public office, its organization and management; personnel administration, position classification and pay plan, staffing patterns, creation of positions, policy formulation for the economical efficient and effective local government administration, conduct and ethical standards for local officials and employees, public accountability of local officials and employees and all matters related to good governance;

- 11) **TAXATION** measures related to local taxes, fees and charges, loans and other sources of local revenues, revision of tax measures including codification of tax ordinances;
- **12) YOUTH AND SPORTS DEVELOPMENT** ordinances in relation to youth welfare and sports development and all such other activities and programs in consonance thereto and the implementation of the constitutional provisions and other laws on youth and sports development;
- 13) SOCIAL SERVICES AND PUBLIC WELFARE ordinances related to public and social welfare and ameliorative services and public social services for the disadvantaged groups, including all matters relative to labor employment, maintenance of industrial peace, promotion of employee-employer cooperation and all other similar matters concerning the general welfare of the city residents and implementation of the provisions of the constitution on social justice;
- 14) WOMEN, CHILDREN AND FAMILY WELFARE all matters related to the protection of women, children and family, measures to protect working women such as safe and healthful working conditions, facilities and opportunities that will enhance their welfare and potentials, measures to protect the rights of spouses and children, including assistance for proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development, measures to protect the rights of families or family associations to participate in the planning and implementation of policies and problems that affect them and all such other similar measures that safeguard the development and welfare of women, children and family;
- **15) PEOPLE EMPOWERMENT** ordinances pertaining to direct and indirect actions of the people concerning their political and socio-economic growth, participation in public hearing and consultation;
- **16) URBAN POOR** measures pertaining to projects, programs, activities to uplift the condition of the marginalized sector of the Urban Poor;
- 17) EDUCATION, ARTS, CULTURE AND HERITAGE matters related to education, schools, libraries, museums, shrines, monuments and other public edifices of historic interest, non-formal and community adult education, implementation of the constitutional provisions on free elementary and secondary education and enrichment of Filipino Arts, Heritage and Culture;
- **18)** LAND USE, URBAN PLANNING AND HOUSING All ordinances relating to urban planning and housing development/programs All matters that relate to real estate and subdivision development, including measures pertaining to land use, zonification and reclassification of land and housing;
- 19) JUSTICE AND HUMAN RIGHTS matters relating to human rights violation and prevention thereof and protection of the natural and legal rights of every person; and

**20) BARANGAY AFFAIRS** – All matters relating to the affairs and activities of all barangays within the City, including the creation of new barangays, merger, abolition or alteration of boundaries of barangays;

**WHEREAS,** the public could easily access any city ordinance and could easily and conveniently download the same for their research and reference;

**WHEREAS,** compilation, arrangement, categorization and display of the ordinances in the official portal of the Sangguniang Panlungsod within the official web site of the city government provide easy and convenient research, study inquiry and examination by the general public;

NOW THEREFORE, on motion of Hon. Jo Abegail C. Dioneda, duly seconded by Hon. Franco Eric O. Ravanilla, resolve as it is hereby resolved to authorize the City Planning and Development Office (CPDO) to display all city ordinances in the apportioned portal reserved for the Sangguniang Panlungsod in the official web site of the city government of Sorsogon;

**RESOLVED FURTHER,** that copies of this resolution be furnished to all concerned for their information and guidance.
