RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BAC-MAN GEOTHERMAL INC. FOR THE ESTABLISHMENT AND ADMINISTRATION OF TRUST ACCOUNTS IN ACCORDANCE WITH DOE DEPARTMENT CIRCULAR NO. DC20018-08-0021 ENTITLED "PROVIDING FOR THE AMENDMENTS TO RULE 29, PART (A) OF THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9136"

WHEREAS, among the items deliberated during the November 19, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the BAC-MAN Geothermal Inc. for the establishment and administration of trust accounts in accordance with DOE Department Circular No. DC20018-08-0021 entitled "Providing for the amendments to Rule 29, part (a) of the implementing rules and regulations of Republic Act No. 9136";

**WHEREAS**, among the mandates of Republic Act No. 7638 also known as the "Department of Energy Act of 1992" is to devise ways to provide direct benefits to the area that hosts energy resources and/or energy generating facilities;

**WHEREAS**, the Department of Energy (DOE) issued regulations for the grant of financial benefits to "host communities of energy resources equivalent to one centavo per kilowatt-hour of the total electricity sales of generation facilities";

**WHEREAS**, Section 66 of RA 9136 otherwise known as the "Electric Power Industry Reform Act of 2001" requires all generation companies and/or energy resource developers to continue providing financial benefits to their host communities;

**WHEREAS**, the City of Sorsogon being the host community of Energy Development Corporation for the longest time intends to avail of this benefit by entering into an agreement with the BAC-MAN Geothermal Incorporated;

**WHEREAS**, attached thereto is the draft Memorandum of Agreement (MOA) for perusal of the August Body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the BAC-MAN Geothermal Inc. for the establishment and administration of trust accounts in accordance with DOE Department Circular No. DC20018-08-0021 entitled "Providing for the amendments to Rule 29, part (A) of the implementing rules and regulations of Republic Act No. 9136";

NOW THEREFORE, on motion of Hon. Franco Eric O. Ravanilla, duly seconded by Hon. Rebecca D. Aquino, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the BAC-MAN Geothermal Inc. for the establishment and administration of trust accounts in accordance with DOE Department Circular No. DC20018-08-0021 entitled "Providing for the amendments to rule 29, part (a) of the implementing rules and regulations of Republic Act No. 9136";
