RESOLUTION ADOPTING AND IMPLEMENTING BUDGET CIRCULAR NO 04, SERIES OF 2020 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT DATED JULY 17, 2020 SUBJECT TO CIVIL SERVICE RULES AND REGULATIONS AND PERTINENT PROVISIONS OF REPUBLIC ACT 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, on July 24, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting for the passage of an ordinance upgrading the Salary Grade of Nurses and Modification of Position Titles and appropriating funds thereof pursuant to Budget Circular No. 2020-04 dated July 17, 2020 of the Department of Budget and Management (DBM);

WHEREAS, attached to the letter request of the Local Chief Executive is a copy of the herein mentioned Memorandum Circular from the Department Budget and Management for perusal of the 7th City Council;

WHEREAS, for purposes of thorough discussion on the issue, the matter was jointly referred to the Committee on Personnel and the Committee on Finance;

WHEREAS, on August 12, 2020, a committee hearing was called for this purpose inviting the presence of concerned department heads and among the recommendations is the passage of this resolution;

WHEREAS, as regards to funds necessary for the implementation of the Memorandum Circular, the same was duly reflected in Resolution No. 173, series of 2020 and Appropriation Ordinance No. 16, series of 2020 passed and approved by the 7th City Council dated July 21, 2020;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution adopting and implementing Budget Circular No. 04, Series of 2020 of the Department of Budget and Management dated July 17, 2020 subject to Civil Service Rules and Regulations and Pertinent Provisions of Republic Act 7160 otherwise known as The Local Government Code of 1991;

NOW THEREFORE, on motion of **City Councilor Ralph Walter R. Lubiano**, duly seconded by **City Councilor Danilo A. Deladia**, resolve as it is hereby resolved to adopt and implement Budget Circular No. 04, Series of 2020 of the Department of Budget and Management dated July 17, 2020 subject to Civil Service Rules and Regulations and Pertinent Provisions of Republic Act 7160 otherwise known as The Local Government Code of 1991;
