RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-FIELD OFFICE V RELATIVE TO SUPPLEMENTARY FEEDING PROGRAM FOR THE PROVISION OF FOOD FOR THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) PROGRAM OF THE GOVERNMENT

WHEREAS, among the items deliberated during the November 19, 2019 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development-Field Office V relative to

Supplementary Feeding Program for the provision of food for the Early Childhood Care and Development (ECCD) program of the government;

WHEREAS, the Food and Nutrition Research Institute of the Department of Science and Technology 8th National Nutrition Survey (2008) revealed the prevalence of under and over nutrition among Filipino children compared to the last survey;

WHEREAS, the Department of Social Welfare and Development (DSWD), in its mandate to provide social welfare and development programs particularly through technical assistance and resource augmentation, provide nutrition services to its clients at the local level through the center-based and community-based services in partnership with Non-Government Organizations (NGO) under the Program Management Bureau, such as the food for School and Health Start Feeding Program in day care centers which were previously implemented nutrition programs of the department;

WHEREAS, malnutrition among children is a problem that needs to be addressed by the government, children who are at-risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished;

WHEREAS, attached thereto is the draft Memorandum of Agreement (MOA) for perusal of the August Body;

NOW THEREFORE, on motion of **Hon. Rebecca D. Aquino**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development - Field Office V relative to Supplementary Feeding Program for the provision of food for the Early Childhood Care and Development (ECCD) program of the government;

RESOLVED FURTHER, that the Memorandum of Agreement entered into by the parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Office of the Secretary to the Sangguniang Panlungsod for records and archive purposes;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
