RESOLUTION RESPECTFULLY REQUESTING MR. WILLIAM E. GANDO, CESO VI, CITY SCHOOLS DIVISION SUPERINTENDENT, SORSOGON CITY TO EXPEDITE THE PROCUREMENT OF MIMEO GRAPHING PAPERS NECESSARY FOR THE IMPLEMENTATION OF MODULAR LEARNING MODALITY SCHEME OF THE DEPARTMENT OF EDUCATION IN ANTICIPATION OF THE OPENING OF CLASSES ON OCTOBER 05, 2020.

WHEREAS, the state gives importance to education in adherence to the 1987 Philippine Constitution, under Article II, Section 17, which states: "The state shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerated social progress and promote total liberation and development";

WHEREAS, RA 9155, otherwise known as the Basic Education Act of 2001, declares that, "it is the State's policy to promote the right of all citizens to quality basic education and make such education accessible to all Filipinos by providing free and compulsory education in the elementary level, and free education in the high level as well as alternative learning system for out-of-school youths and adult learners";

WHEREAS, among the 10-Point Agenda of the present administration are the Sulay sa Futuro (Youth Assistance Program) and the YES! to Children Assistance Program which shall provide hope among our youth and children to continue their education in the midst of the pandemic and under the new normal learning strategies;

**WHEREAS**, amid COVID 19 Pandemic, the Department of Education (DepEd) in compliance with Health Protocols imposed by appropriate government agencies adopted Modular Learning Modality Scheme as part Social Distancing among teachers and learners being vulnerable to said pandemic;

**WHEREAS**, the immediate response of the City Government of Sorsogon, through the leadership of Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City is to provide 3 (three) Risograph Machines which is now on its way for delivery;

WHEREAS, said Risograph machines will help reproduce Modular Learning Modality of students and in addition thereof, the City Mayor undertakes to shoulder manpower deployment as operators of Risograph machines, maintenance and power consumption of the equipment;

WHEREAS, in view of the foregoing, it is therefore humbly requested to expedite the procurement of mimeo graphing papers necessary for the implementation of modular learning modality scheme of the Department of Education in anticipation of the opening of classes on October 05, 2020;

NOW THEREFORE, on incidental motion of City Councilor Franco Eric O. Ravanilla, duly seconded by City Councilor Danilo A. Deladia, resolve as it is hereby resolved to request Mr. William E. Gando, CESO VI, City Schools Division Superintendent, Sorsogon City to expedite the procurement of mimeo graphing papers necessary for the implementation of Modular Learning Modality Scheme of the Department of Education in anticipation of the opening of classes on October 05, 2020;
