WHEREAS, among the items deliberated during the November 19, 2019 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with Department of Information and Communications Technology (DICT) represented by Cheryl C. Ortega, Regional Director relative to the Tech4ed Program;

WHEREAS, Tech4Ed stands for Technology Empowerment for Education, Employment, Entrepreneurs and Economic Development is a program of the Department of Information and Communications Technology (DICT) which aims to provide access to information and government services to areas that need it the most;
