MERLA REBECHÉ, OIC-DISTRICT ENGINEER, 1ST ENGINEERING DISTRICT, PROVINCE OF SORSOGON TO ALLOCATE FUNDING FOR THE CONSTRUCTION OF COVERED COURT IN BARANGAY CAPUY, WEST DISTRICT, SORSOGON CITY.
