RESOLUTION ENDORSING THE FARM – TO – MARKET ROAD PROJECTS WITHIN THE CITY OF SORSOGON TO THE DEPARTMENT OF AGRICULTURE AND WITH THE MANIFESTATION OF COMMITMENT TO PROVIDE COUNTERPART FUNDING OF AT LEAST 10 PERCENT OF THE PROJECT COST

WHEREAS, on November 26, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary respectfully requesting for the passage of a resolution endorsing the Farm – To – Market Road Projects within the City of Sorsogon to the Department of Agriculture;

WHEREAS, this is in connection with the request of the chief executive thru the Office of the Department of Agriculture Secretary William D. Dar relative to the funding for the construction of Farm-to Market Roads (FMR) Roads within the City Of Sorsogon;

WHEREAS, among the documentary requirements presented is a resolution endorsing the project(s) and stating the commitment to provide at least ten (10%) percent counterpart for the completion thereof specifically described below as follows:

- 1. Concreting of Farm to Market Road at San Isidro, West District, Sorsogon City;
- 2. Concreting of Farm to Market Road at Bulabog, West District, Sorsogon City;
- 3. Concreting of Farm to Market Road at San Pascual, Bacon District, Sorsogon City;
- 4. Concreting of Farm to Market Road at Salvacion, Bacon District, Sorsogon City;
- 5. Concreting of Farm to Market Road at San Vicente Sta. Lucia, Bacon District, Sorsogon City;
- 6. Concreting of Farm to Market Road at Sta. Cruz, Bacon District, Sorsogon City;
- 7. Road Opening at Salvacion, West District, Sorsogon City;
- 8. Road Opening at Panlayaan, West District, Sorsogon City;
- 9. Road Opening at Rizal, West District, Sorsogon City;
- 10. Road Opening at Macabog, West District, Sorsogon City; and
- 11. Road Opening at Rawis, Bacon District, Sorsogon City.

WHEREAS, Farm—to—Market Roads and Road Opening are among the long term goals of the city government for the improvement of access roads which shall not only pave way for easier access of those who are residing in remote areas but shall enhance the mobility of agricultural commodities as well;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th city council deemed it necessary to pass a resolution endorsing the Farm-To-Market Road Projects within the City of Sorsogon to the Department of Agriculture and with the manifestation of commitment to provide counterpart funding of at least 10 percent of the project cost;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to endorse the Farm–To–Market Road Projects within the City of Sorsogon to the Department of Agriculture and with the manifestation of commitment to provide counterpart funding of at least 10 percent of the project cost;
