RESOLUTION APPROVING THE HEREUNDER STATED BARANGAY SUPPLEMENTAL/ANNUAL BUDGETS OF VARIOUS BARANGAYS OF WEST DISTRICT IN THE CITY OF SORSOGON

WHEREAS, as mandated by law and under the existing internal rules, annual budgets and any appropriation of funds within the jurisdiction of the City of Sorsogon, shall pass before the Sangguniang Panlungsod for further review and approval;

WHEREAS, the above stated budget show strict compliance in substance with the Commission on Audit budgeting laws, rules and regulations, and the same was in accordance with the mandate of implementing circulars of the City Government of Sorsogon;

WHEREAS, the members of the Sangguniang Panlungsod, after thorough study and scrutiny on the items appropriated thereto and after formal deliberation respecting the internal rules, has finally decided to pass said supplemental budgets;

NOW THEREFORE, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Hon. Mary Ellen D. Jamisola**, resolve as it is hereby resolved to approve the hereunder stated Barangay Supplemental/Annual budgets of various barangays of West District in the City of Sorsogon with their corresponding appropriations subject however to the following condition/s also hereunder stipulated:

1. Barangay Supplemental Budget No. 01, FY 2020	Bulabog, West District	₱ 297,595.46
2. Barangay Supplemental Budget No. 002, FY 2020	Cambulaga, West District	₱ 91,360.00

1. That the implementation for development projects funded out of the 20% IRA should follow the identified priorities under Joint Memorandum Circular No. 2017-1 of the DILG and the DBM dated February 22, 2017 and additional guidelines under Joint Memorandum Circular No. 01 of the DILG and the DBM dated March 27, 2020 and must be in accordance with Section 287, R. A. No. 7160 and must be properly approved by the Barangay Development Council and must be observed the procedural requirements under R. A. 7160, and in accordance with the approved FY 2020 AIP.
2. That the disbursement of all appropriations herein authorized shall be subject to the usual accounting and auditing rules and regulations and subject to cash availability of barangay funds.
3. In view thereof, this Supplemental Budget may be considered operative as of the fixed in its enabling ordinance and copies of it must be furnished to the COA, DILG, City Budget Office and Office of the City Accountant for their information.

Accordingly, the said Appropriation Ordinance is declared operative in its entirety subject to the posting requirement under Section 59 of R.A. No. 7160.

It is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

Compliance with all existing laws, rules and regulations shall be the responsibility of the barangay.

1. Barangay Supplemental Budget No. 02, FY 2020	San Isidro, West District	₱ 224,945.56

1. That the grant of Covid-19 Hazard Pay in LGUs/Barangays must be in accordance to Section 5 of Administrative Order No. 26 and Item 7.0 of Budget Circular No. 2020-1 dated March 24, 2020 and shall be subject to Personnel Services limitation under Republic Act No. 7160.

2. That the rant of annual leave benefits of barangay should adhere to the pertinent provisions of LBC No. 85 dated April 23, 2007 and must be subject to the fifty five percent (55%) limitation on Personal Services.
3. The amount of Three Hundred Sixteen Pesos & 15/100 (₱ 316.15) is already excess over PS Limitation.
4. That the disbursement of all appropriations herein authorized shall be subject to the usual accounting and auditing rules and regulations and subject to cash availability of barangay funds.
5. In view thereof, this Supplemental Budget may considered operative as of the fixed in its enabling ordinance and copies of it must be furnished to the COA, DILG, City Budget Office and Office of the City Accountant for their information.

3. In view thereof, this Supplemental Budget may considered operative as of the fixed in its enabling ordinance and copies of it must be furnished to the COA, DILG. City Budget Office and Office of the City Accountant for their information.

2. That the disbursement of all appropriations herein authorized should be subject to the usual accounting and auditing rules and regulations and subject to cash availability of barangay funds
3. In view thereof, this Supplemental Budget may be considered operative as of the fixed in its enabling ordinance and copies of it must be furnished to the COA, DILG, City Budget Office and Office of the City Accountant for their information.

Accordingly, the said Appropriation Ordinance is declared operative in it's entirely, subject to the posting requirement under Section 59 of R.A. No. 7160.

It is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provision of law.

That the utilization of SK Fund must be in accordance with DBM – DILG – National Youth Commission (NYC) JMC No. 1 dated January 23, 2019 and priority should be given to youth development and empowerment programs, projects and activities in accordance with the Philippine Youth Development Plan and Local Youth Development Plan, as embodied in the approved CBYDP and ABYIP CY 2020.
2. That the disbursement of all appropriations herein authorized should be subject to the usual accounting and auditing rules and regulations and subject to cash availability of Sangguniang Kabataan funds and copies of it must be furnished to the COA, DILG, City Budget Office and Office of the City Accountant for their information.


Adjustment in the appropriation should be made in case of overdraft or imminence thereof before the end of the fiscal year.

Accordingly, the said Appropriation Ordinance is declared operative in its entirety and it is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provision of law.

Compliance with all existing laws, rules and regulations shall be the responsibility of the barangay.
