WHEREAS, Section 16 of RA 10121, otherwise known as the "Philippine Disaster Risks Reduction and Management Act of 2010", states that "... xxxx The declaration and lifting of the state of calamity may also be issued by the local sanggunian, upon the recommendation of the LDRRMC, based on the results of the damage assessment and needs analysis;

WHEREAS, Section 6.3 of the NDRRMC – DBM – DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 entitled "Allocation and Utilization of the Local DRRM Fund" states that "the release and use of the 30% QRF shall be supported by a resolution to the local sanggunian declaring the LGU under the State of Calamity or a Presidential declaration of state of calamity upon the recommendation of NDRRMC;

WHEREAS, after the destruction of Typhoon "Tisoy" it creates **heavy dam**age and dilapidated residential structures and houses of light materials in the Sorsogon City;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7^{th} City Council deemed it necessary to pass a resolution declaring Sorsogon City under the State of Calamity;

NOW THEREFORE, on motion of **Hon. Mary Ellen D. Jamisola** and unanimously approved by the body resolve as it is hereby resolved to declare Sorsogon City under the State of Calamity;

EXCERPTS FROM THE MINUTES OF THE EMERGENCY MEETING OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) HELD AT THE DISASTER OPERATION CENTER (DOPCEN) ON 03 DECEMBER 2019.

CDRRMC RESOLUTION NO. 007-2019

RECOMMENDING TO THE SANGGUNIANG PANLUNGSOD TO DECLARE THE CITY OF SORSOGON UNDER THE STATE OF CALAMITY

WHEREAS, Section 16 of RA 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010", states that "...xxxx The declaration and lifting of the state of calamity may also be issued by the local sanggunian, upon the recommendation of the LDRRMC, based on the results of the damage assessment and needs analysis."

WHEREAS, Section 6.3 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 entitled "Allocation and Utilization of the Local DRRM Fund" states that "the release and use of the 30% QRF shall be supported by a resolution to the local sanggunian declaring the LGU under the State of Calamity or a Presidential declaration of state of calamity upon the recommendation of NDRRMC".

WHEREAS, per PAGASA Severe Weather Bulletin #16 on Typhoon "TISOY", issued at 5:00AM today, 03 December 2019, the Province of Sorsogon is STILL under Tropical Cyclone Wind Signal No. 3 with maximum sustained winds of 155 km/h and gustiness of up to 235 km/h;

WHEREAS, per PAGASA Heavy Rainfail Warning #7, issued at 6:00AM today, 03 December 2019, Sorsogon is under Orange Warning and Alert Level which means that flooding is threatening in low-lying areas;

WHEREAS, ALL barangays especially in high-risk areas, implemented pre-emptive evacuation in preparation for Typhoon Tisoy and per record of the City Social Welfare and Development Office (CSWDO) 5,702 families or 19,987 individuals evacuated as of 6:00PM, 02 December 2019;

WHEREAS, it is the consensus of this body to provide immediate relief services and assistance to the evacuees;

NOW THEREFORE, on motion of CENRO Ronando F. Gerona Jr., duly seconded by GAD Focal Person Ma. Rosy Abay, resolve as it is hereby resolved to recommend the declaration of state of calamity in the City of Sorsogon.

RESOLVED FINALLY, that copies of this resolution and minutes of the meeting be furnished to all members of CDRRMC.
