RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A JOINT VENTURE AGREEMENT (JVA) WITH MR. LAWRENCE P. LUBIANO, PRESIDENT, GREENWAYS WASTE MANAGEMENT SERVICES IN RELATION TO THE ESTABLISHMENT OF A REFUSE-DERIVED FUEL (RDF) FACILITY AT THE CITY MATERIAL RECOVERY FACILITY (CMRF) SITE LOCATED AT BARANGAY BUHATAN, EAST DISTRICT, SORSOGON CITY.

WHEREAS, on August 20, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor respectfully requesting for the passage of a resolution authorizing the local chief executive to enter into a Joint Venture Agreement with Mr. Lawrence P. Lubiano, President, Greenways Waste Management Services in relation to the establishment of a Refuse-Derived Fuel (RDF) Facility at the City Material Recovery Facility (CMRF) Site located at Barangay Buhatan, East District, Sorsogon City;

WHEREAS, as contained in the letter of the local chief executive, said endeavour intends to address the pressing solid waste management concern in the territorial jurisdiction of the City of Sorsogon;

WHEREAS, for purposes of this resolution, attached to the letter request are as follows;

1. Draft Joint Venture Agreement (JVA);
2. Barangay Resolution No. 29, series of 2020 from the Barangay Council of Barangay Buhatan, East District, Sorsogon City dated August 20, 2020 entitled "RESOLUTION INTERPOSING NO OBJECTION TO THE PLAN OF THE CITY GOVERNMENT OF SORSOGON TO OPERATE THE BUHATAN CITY LEVEL MATERIAL RECOVERY FACILITY AS REFUSE-DERIVED FUEL (RDF) WITHIN THE END VIEW OF REDUCING WASTE THROUGH RECOVERY AND RECYCLING BEING DUMP AT THE FINAL DISPOSAL SITE"; and
3. Greenways Waste Management Services Letter of Intent.

WHEREAS, for record purposes, the Hon. Ralph Walter R. Lubiano expressly inhibited himself from the deliberation and approval of this resolution;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Joint Venture Agreement with Mr. Lawrence P. Lubiano, President, Greenways Waste Management Services in relation to the establishment of a Refuse-Derived Fuel (RDF) Facility at the City Material Recovery Facility (CMRF) Site located at Barangay Buhatan, East District, Sorsogon City;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Danilo A. Deladia**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Joint Venture Agreement with Mr. Lawrence P. Lubiano, President, Greenways Waste Management Services in relation to the establishment of a Refuse-Derived Fuel (RDF) Facility at the City Material Recovery Facility (CMRF) Site located at Barangay Buhatan, East District, Sorsogon City;

RESOLVED FURTHER, that the Joint Venture Agreement entered into by parties herein mentioned shall be an integral part of this resolution;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information, guidance and most appropriate action.


