**RESOLUTION REQUESTING PBGEN ANTHONY S. ALCANESES, REGIONAL DIRECTOR, POLICE REGIONAL OFFICE V. CAMP GEN. SIMEON A. OLA, LEGAZPI CITY FOR AT LEAST THREE (3) UNITS OF PATROL CARS FOR THE SORSOGON CITY PNP**

**WHEREAS**, the Office of the City Mayor and the Sangguniang Panlungsod were in receipt of a request from the Sorsogon City PNP relative to the passage of a resolution requesting for an additional mobility asset for their continues, effective and efficient operation;

**WHEREAS**, at present, the Sorsogon City PNP has two (2) units of Hilux which have been in operation for more than 10 years now and a Mahindra that requires high maintenance ergo expenses;

**WHEREAS**, this measure shall serve as compliance with the documentary requirements set forth under Memorandum Circular No. 2009-003 prescribing for the “Guidelines in the issuance and markings of the PNP Mobility Assets”;

**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the ***promotion of the general welfare***. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, ***maintain peace and order and preserve the comfort and convenience of their inhabitant***;

**NOW THEREFORE**, on incidental motion of **Hon. Danilo A. Deladia**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to pass a resolution requesting PBGen Anthony S. Alcaneses, Regional Director, Police Regional Office V. Camp Gen. Simeon A. Ola, Legazpi City for at least three (3) units of patrol cars for the Sorsogon City PNP;
