**RESOLUTION RECOMMENDING THE APPROVAL OF THE APPLICATION FOR RELEASE ON RECOGNIZANCE OF BRUCE VILLANUEVA y LOPEZ, ACCUSED, FILED AT THIS HONORABLE COURT, REGIONAL TRIAL COURT, BRANCH 52, FIFTH JUDICIAL REGION, SORSOGON CITY.**

**WHEREAS**, the Sangguniang Panlungsod, Sorsogon City was furnished with the notice, receipt thereof of the Sangguniang Panlungsod dated September 03, 2020, from this Honorable Court vis a vis the application/motion for the release of the accused on recognizance as embodied in Republic Act 10389 under Criminal Case Nos. 2020-11409 and 2020-11410 for: VIOLATION OF SEC. 5 & 11, ART. II OF R. A. 9165;

**WHEREAS**, on occasion of the Regular Session of the City Council on September 08, 2020 after deliberations, the august body firmly believes that the applicants deserve compassion, being that he is indigent and anchored on the maxim that “those who have less in life must have more in law” and that he be released on recognizance to the custody of a qualified residents of Barangay San Juan (Roro), East District, Sorsogon City or to any qualified resident of Sorsogon City, as the case maybe, pursuant to R.A. No. 10389, upon compliance of the requirements set forth thereunder;
