RESOLUTION ADOPTING EXECUTIVE ORDER NO. 32, SERIES OF 2020 ENTITLED "AN ORDER MANDATING THE TEMPORARY CLOSURE OF ALL PUBLIC AND PRIVATE MEMORIAL PARKS AND CEMETERIES FROM OCTOBER 31 TO NOVEMBER 03, 2020 IN THE CITY OF SORSOGON

WHEREAS, on September 11, 2020 Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City issued Executive Order No. 32 mandating the temporary closure of all public and private memorial parks and cemeteries from October 31 to November 03, 2020 in the City of Sorsogon;

WHEREAS, the said executive order is in consonance with Proclamation No. 922 which enjoins all government agencies and Local Government Units (LGUs) to render full

assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate responses and measures in a timely manner to curtail and eliminate the COVID 19 threat;

WHEREAS, as provided under Paragraph A (4) (d) of IATF Resolution No. 43 approved on June 03, 2020 which states that "Mass gatherings such as but not limited to, movie screenings, concerts, sporting events and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to fifty percent (50%) of the seating or venue capacity;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution adopting Executive Order No. 32, Series of 2020 entitled "An order mandating the temporary closure of all public and private memorial parks and cemeteries from October 31 to November 03, 2020 in the City of Sorsogon;

**NOW THEREFORE**, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Erwin J. Duana**, resolve, as it is hereby resolved to adopt Executive Order No. 32, Series of 2020 entitled "An order mandating the temporary closure of all public and private memorial parks and cemeteries from October 31 to November 03, 2020 in the City of Sorsogon;
