RESOLUTION RESPECTFULLY ENDORSING TO THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY FOR APPROPRIATE ACTION THE REQUEST OF SENIOR CITIZEN ORGANIZATION OF BARANGAY PANGPANG, WEST DISTRICT, SORSOGON CITY

WHEREAS, on September 07, 2020, Mrs. Zenaida L. Magbanua, President, Senior Citizen Organization, Barangay Pangpang, West District, Sorsogon City wrote a letter addressed to the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City respectfully requesting for the donation of portion of lot being occupied by the Senior Citizen Organization;

WHEREAS, discussion thereof reveals that the senior citizen building at issue was constructed at an open space located at 5th Street OLV Pangpang just beside the barangay market and the same had been there for sometime already;

WHEREAS, for purposes of this resolution, it was the recommendation of the Hon. Baldon to grant the request, however, in consonance with relevant existing laws, the Hon. Laura suggested that a Conditional Use of the portion at issue in favour of Senior Citizen would be appropriate;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod deemed it wise to refer the matter to the local chief executive for appropriate action with the recommendation that a Conditional Use/Usufruct Agreement of the portion at issue be given instead of a Deed of Donation;

Ravanilla**, resolve as it is hereby resolved to pass a resolution respectfully endorsing to the Hon. M. Ester E.
