RESOLUTION REQUESTING THE UNDERSECRETARY EARL P. SAAVEDRA, EXECUTIVE DIRECTOR, DANGEROUS DRUGS BOARD (DDB) TO CONDUCT TRAINING OF TRAINERS OF THE UNIVERSAL PREVENTION CURRICULUM (UPC) FOR SUBSTANCE USE IN SORSOGON CITY

WHEREAS, Executive Order No. 66, ordered and signed by President Rodrigo Roa Duterte mandates all government offices, including government-owned and controlled corporations and state universities and colleges, to implement the Philippine Anti-illegal Drug Strategy (PADS) that aims to boost government's ongoing anti-narcotics campaign;

**WHEREAS**, the Dangerous Drugs Board (DDB) is the policy making and strategyformulating body in the planning and formulation of policies and programs on drug prevention and control; **WHEREAS,** the Dangerous Drugs Board (DDB) initiates programs geared towards preventive education, alternative development, public awareness and international cooperation;

WHEREAS, the relentless campaign being implemented by law enforcement agencies, educational institutions, non-government and civic organizations and other stakeholders will in all probability reduce drug addiction in Sprsogon City;

NOW THEREFORE, on motion of Hon. Mary Ellen D. Jamisola, duly seconded by Hon. Franco Eric O. Ravanilla, resolve as it is hereby resolved to respectfully request the Undersecretary Earl P. Saavedra, Executive Director, Dangerous Drugs Board (DDB) to conduct training of trainers of the Universal Prevention Curriculum (UPC) for substance use in Sorsogon City.
