RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION FOR THE CONSTRUCTION OF PIGGERY HOUSE/PIG PEN OF MRS. MARYJOY E. MENGORIO, OWNER, THIRDY'S PIGGERY LOCATED AT BARANGAY STO. DOMINGO, BACON DISTRICT, SORSOGON CITY

WHEREAS, on September 09, 2020, Mrs. Maryjoy E. Mengorio, Owner, THIRDY's Piggery wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, through Mr. Rovon E. Domasian, Acting Secretary to the Sangguniang Panlungsod respectfully requesting for the passage of resolution applicant's request for the construction of piggery house/pig pen on her piggery farm located at Barangay Sto. Domingo, Bacon District, Sorsogon City;

WHEREAS, among the documents submitted in support of the applicant's request are as follows;

1. Inspection Report of the City Health Office dated August 24, 2020 with the recommendation that the site conformed with the required distance for any animal raised such as piggery and any other animal to raise as issued by Ms. Marilou D. 2. Barangay Resolution No. 020, series of 2020 from the Barangay Council of Barangay Sto. Domingo, Bacon District, Sorsogon City dated September 06, 2020 entitled "Resolution Approving to Put Up and Operate a Piggery Business in the Barangay;

WHEREAS, foregoing premise considered, the 7th City Council deemed it necessary to pass a resolution interposing no objection on the application for the construction of piggery house/pig pen of Mrs. Maryjoy E.
