RESOLUTION ADOPTING WITH AMENDMENTS THE LEGAL OPINION ISSUED BY ATTY. ROBERTO T. LABITAG, CITY LEGAL OFFICER DATED AUGUST 27, 2020 IN RELATION TO SALANDANAN'S CLAIM FOR JUST COMPENSATION OF LOT 3320, SORSOGON CADASTRE; A PORTION OF WHICH HAD BEEN TAKEN DECADES AGO BY THE THEN MUNICIPALITY OF SORSOGON AND TURNED TO A PUBLIC STREET

WHEREAS, on August 27, 2020, Atty. Roberto T. Labitag, City legal Officer Sorsogon City issued a Memorandum for the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City; Hon. Mark Eric C. Dioneda, City Vice Mayor and Hon. Nestor J. Baldon, City Councilor rendering his Legal Opinion in relation to Salandanan's Claim for Just Compensation of Lot 3320, Sorsogon Cadastre; A Portion of Which had been taken decades ago by the then Municipality of Sorsogon and turned to a public street;

WHEREAS, the matter was among the items deliberated upon by the City Council and upon recommendation of the Hon. Laura, the same was adopted subject to amendment of the recommendation in the Legal Opinion which shall now read as follows;

#### V. Recommendation.

In view of the foregoing, it is respectfully recommended that the claim for just compensation by Mr. Ignacio J. Salandanan, Jr., et. al. **be hold in abeyance** for the time being until a judgement for payment thereof, as rendered by a court of competent jurisdiction upon a petition by the claimants, shall become final and executory.

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution adopting with amendments the Legal Opinion issued by Atty. Roberto T. Labitag, City Legal Officer dated August 27, 2020 in relation to Salandanan's Claim for Just Compensation of Lot 3320, Sorsogon Cadastre; A Portion of Which had been taken decades ago by the then Municipality of Sorsogon and turned to a public street;
