HAMOR, CITY MAYOR, SORSOGON CITY TO AUTHORIZE THE INCREASE OF MONTHLY STIPEND OF CONTRACTUAL EMPLOYEES, BARANGAY HEALTH WORKERS (BHW), ASSOCIATE BARANGAY HEALTH WORKERS, BARANGAY NUTRITION SCHOLAR (BNS), DAYCARE WORKERS AND CONSULTANTS OF THE CITY OF SORSOGON IN THE AMOUNT OF FIVE HUNDRED (P500.00) PESOS EFFECTIVE JULY 2019 TO DECEMBER 2019.**

**WHEREAS, in order to augment its present workforce and in order to ensure the delivery of basic services to the local populace, the City Government of Sorsogon entered into Contract of Service to contractual employees paid through monthly stipends;**
