# RESOLUTION CONDEMNING IN STRONGEST TERMS THE SENSELESS KILLING OF MR. JOEBERT "POLPOG" BERCASIO ON SEPTEMBER 14, 2020

WHEREAS, Mr. Joebert "Polpog" Bercasio, a prominent media practitioner and a Social Media Platform Host of Kurahaw Bicolandia and Balangibog Internet TV was senselessly murdered by an Unidentified Riding in Tandem while on his way home at around 7:00 p.m. to 8:00 p.m. outside the Seabreeze Homes Subdivision along Maharlika Highway of Barangay Cabid-an, East District, Sorsogon City;

**WHEREAS,** the victim is one of the hard hitting commentators in his program in the Social media platform discussing pressing issues in Sorsogon and the neighbouring provinces;

**WHEREAS**, the incident sparked indignation among fellow media practitioners, friends and listeners of the victim calling for an immediate investigation, apprehension of the culprits and justice for the bereaved family of the victim;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution condemning in Strongest terms the Senseless Killing of Mr. Joebert "Polpog" Bercasio on September 14, 2020;

**NOW THEREFORE,** on unanimous accord, resolve as it is hereby resolved to condemn in Strongest terms the Senseless Killing of Mr. Joebert "Polpog" Bercasio on September 14, 2020;

**RESOLVED FURTHER** that copies of this resolution be furnished to the bereaved family of Mr. Joebert Bercasio with sincerest condolences from the 7<sup>th</sup> City Council.
