RESOLUTION ENCOURAGING THE BARANGAYS, PRIVATE AND PUBLIC ESTABLISHMENTS TO CONDUCT REGULAR FOGGING DISINFECTION ACTIVITIES TO AVOID POSSIBLE WIDESPREAD TRANSMISSION OF COVID 19 IN THE CITY OF SORSOGON

WHEREAS, traditional method/system in dispensing disinfectants in any establishments in the city of Sorsogon does not provide assurance eliminating or avoiding community or widespread transmission of COVID 19;

WHEREAS, fogging disinfection is believed to be and considered as more effective than the liquid disinfection method and therefore could at least provide assurance to minimize the possibility of community transmission of the virus;

WHEREAS, introduction and the conduct of regular fogging disinfection in the barangays and to all private and public establishments in the city of Sorsogon, is another tool to combat COVID 19 and to avoid the widespread of the virus in the communities;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the ***promotion of the general welfare***. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, ***promote health and safety***, improve public morals, enhance economic prosperity and social justice, maintain peace and order and ***preserve the comfort and convenience of their inhabitant***;

NOW THEREFORE, on motion of **Hon. Mark Eric C. Dioneda**, duly seconded by the **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to pass a resolution encouraging the barangays, private and public establishments to conduct regular fogging disinfection activities to avoid possible widespread transmission of Covid 19 in the city of Sorsogon.
