RESOLUTION EXPRESSING NO OBJECTION TO THE PROPOSED RECLAMATION PROJECT OF THE CITY OF SORSOGON AND THEREBY AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO FILE AN APPLICATION WITH THE PHILIPPINE RECLAMATION AUTHORITY RELATIVE THERETO

WHEREAS, the City Government has already completed the construction of the first phase of Sorsogon City Coastal Road from Barangay Talisay to Barangay Cabid-an in order to provide alternate route to all kinds of vehicles and thereby decongest traffic at the central business district;

**WHEREAS,** the finished government project will be a flood mitigating structure, open roads for garbage collection and fire trucks in case of fire incident on coastal barangays of East District, Sorsogon City;

**WHEREAS,** offshore areas adjacent to the Sorsogon Bay Coastal Road are covered by the proposed reclamation project of the City Government intended for onsite housing program for informal settlers and commercial/business establishments;

**WHEREAS,** it is the mandate for the local government unit to exercise the powers expressly granted, those necessarily implied there from, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS,** foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution expressing no objection to the proposed reclamation project of the City of Sorsogon and thereby authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to file an application with the Philippine Reclamation Authority relative thereto;

**NOW THEREFORE**, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Rebecca D. Aquino**, resolve, as it is hereby resolved to express no objection to the proposed reclamation project of the City of Sorsogon and thereby authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to file an application with the Philippine Reclamation Authority relative thereto;
