RESOLUTION REQUESTING THE CITY GOVERNMENT OF SORSOGON THROUGH HON. CITY MAYOR MA. ESTER E. HAMOR TO ESTABLISH BICYCLE REPAIR STATIONS IN ALL STRATEGIC LOCATION IN THE CITY JURISDICTION, SERVICES FREE OF CHARGE FOR THE BENEFITS OF THE LOCAL WORKERS IN PUBLIC AND PRIVATE SECTOR AND BICYCLE ATHLETES AND ENTHUSIASTS

WHEREAS, during the period of community quarantine that allows certain percentage for the operation of transport sector, bicycle became the most reliable mode of transportation to many;

WHEREAS, subject to strict compliance of the requirements and protocols to avoid community transmission of Covid 19 virus, the use of bicycle as a mode of transportation and as a health working gadget was encouraged;

WHEREAS, biking activity as a form of routine exercise provides multiple health rewards in improving human wellbeing not to mention its contribution in minimizing the presence of air pollution and its environmentally friendly impact to ecological balance;

WHEREAS, the same also lessens family expenses scrapping large amount allocated for high rising gasoline consumption thereby improving personal and family economic capability;

WHEREAS, the city government, through the Local Chief Executive is requested to establish bicycle repair stations in strategic locations in the city of Sorsogon, wherein bicycles in need of minor repair/s could be fixed free of charge;

WHEREAS, bicycle repair stations, as herein requested should be provided with the usual tools, implements and kits for minor repairs, available at any time of the day;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to pass a resolution requesting the city government of Sorsogon through Hon. City Mayor Ma. Ester E. Hamor to establish bicycle repair stations in all strategic location in the city jurisdiction, services free of charge for the benefits of the local workers in public and private sector and bicycle athletes and enthusiasts.
