**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF "ENCONTRADA" ON DECEMBER 23, 24, 26, 31, 2019 AND JANUARY 2, 2020 AT THE SORSOGON CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the December 17, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Mr. Rico Ortiz dated December 6, 2019 requesting for a passage of a resolution approving and authorizing the conduct of "encontrada" at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City on **December 23, 24, 26, 31, 2019 and January 2, 2020;**

**WHEREAS**, as reflected in the request, it is stated that portion of the proceeds will be donated to the charitable institutions of their choice;

**WHEREAS**, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to identified charitable institutions in the City of Sorsogon and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the city;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution approving and authorizing the conduct of "encontrada" on December 23, 24, 26, 31, 2019 and January 2, 2020 at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladla**, resolve as it is hereby resolved to approve and authorize the conduct of an "encontrada" on December 23, 24, 26, 31, 2019 and January 2, 2020 at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**RESOLVED FURTHER**, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;
