# Resolution No. 234, Series of 2019

RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO FACILITATE THE INSPECTION, APPRAISAL, AND POSSIBLE CONDEMNATION AND DEMOLITION OF VARIOUS STRUCTURES/INFRASTRUCTURES IN THE CITY OF SORSOGON

WHEREAS, among the items deliberated during the December 17, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from the Chief Executive dated December 16, 2019 requesting for a passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to facilitate the inspection, appraisal, and possible condemnation and demolition of various structures/ infrastructure in the City of Sorsogon;

WHEREAS, there are different government properties and structures of the City Government which needs to be inspected, appraised, and identify for possible condemnation and demolition which would cause harm to the general public and obstruction to the new development;

**WHEREAS,** among the identified government properties and structures are the following:

 ROTONDA at Magsaysay St. which needs to be demolish for it will obstruct the installation of traffic lights at the section road

PERIMETER FENCE at Plaza Bonifacio, Sirangan, which needs to be removed for it is already deteriorating and obstruction to the development and

construction of an elevated parking

WOODEN STAGE at the Rompeolas for it is already considered dangerous and

ruinous

 PUBLIC TOILET, CONCRETE BENCHES & KIOSK and PILI STRUCTURE at the Sorsogon Baywalk are also affected by the impending

development/improvement of greening of rompeolas project.

WHEREAS, pursuant to National Building Code, also known as Presidential Decree 1096, there are technical requirements to follow in constructing or renovating buildings and structures in the Philippines to secure the life, health, property and

welfare of the Filipinos;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to facilitate the inspection, appraisal, and possible condemnation and demolition of various

structures/infrastructures in the City of Sorsogon;

NOW THEREFORE, on motion of Hon. Erwin J. Duana, duly seconded by Hon. Franco Eric O. Ravanilla, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to facilitate the inspection, appraisal, and possible condemnation and demolition of the various structures/infrastructure in the City of

Sorsogon.
