RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH RAMESES SYSTEMS, INC., REPRESENTED BY MR. ELMO M. NAZARENO, PRESIDENT AND CEO OF RAMESES SYSTEMS, INC. FOR THE IMPLEMENTATION OF E-TRACS SUSTAINABILITY PROGRAM.

WHEREAS, the City Government of Sorsogon has been using the Enhanced Tax Revenue Assessment and Collection System (E-TRACS) since 2017 for business permits, real property assessment and tax collection;

WHEREAS, in order to ensure the long-term success of the program, continues innovation and sustainability is therefore an utmost necessity;

WHEREAS, the Enhanced Tax Revenue Assessment and Collection System (E-TRACS) Sustainability Program of the city government of Sorsogon was organized by RAMESES System. Inc.:

WHEREAS, RAMESES System. Inc., the system developer of the E-TRACS provides assurance for the continuity of technical support and software update for the benefits of the city government;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;
