RESOLUTION URGING MS. LORNA D. BALETA OF THE CITY TRICYCLE FRANCHISING REGULATORY OFFICE TO FURNISH THE SANGGUNIANG PANLUNGSOD COPIES OF THE LISTS OR ACTUAL NUMBER OF TRICYCLE FRANCHISES IN RECORD IN THE SPIRIT OF TRANSPARENCY

WHEREAS, the measure was discussed during the September 22, 2020 Regular Session under item 9.1 in its calendar of business;

WHEREAS, in the Bill of Rights enshrined in the Constitution, the right to property, policy of full disclosure of all transactions involving public interest and the right of the people to information on matters of public concern are given top cognizance;

WHEREAS, Article II and III of the Philippine Constitution states that subject to reasonable conditions prescribed by law, the State adopts and implements a policy of full disclosure of all

transactions involving public interest and recognizes the right of the people to information on matters of public concern;

WHEREAS, Republic Act 9485 otherwise known as the Anti-Red Tape Law (ARTA) of 2007 mandates all government offices to simplify frontline service procedures, formulate service standards to observe in every transaction and make known these standards to their clients;

WHEREAS, every local government unit shall exercise the powers expressly granted. Those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to urge Ms. Lorna D. Baleta of the City Tricycle Franchising Regulatory Office to furnish the Sangguniang Panlungsod copies of the lists or actual number of tricycle franchises in record in the spirit of transparency.
