RESOLUTION APPEALING BEFORE THE SANGGUNIANG PANLALWIGAN THE DECLARATION AS INVALID SORSOGON CITY ORDINANCES PREVIOUSLY SUBMITTED FOR REVIEW AND INSTEAD THE SAME BE DECLARED REMANDED TO THE SANGGUNIANG PANLUNGSOD FOR COMPLIANCE PURPOSES.

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 and its Implementing Rules and regulations mandates that relevant ordinances and resolutions of the Sangguniang Panlungsod shall be submitted for review to the Sangguniang Panlalawigan being a component city;

WHEREAS, the review action to be undertaken by the Sangguniang Panlalawigan however shall be limited to whether or not the submitted ordinances by the Sangguniang Panlungsod is within the powers and functions as enumerated under Section 458 of the Local Government of 1991;

WHEREAS, just previously some ordinances were submitted to the Sangguniang Panlalawigan for review and after deliberations thereof, the same was declared invalid as reflected in the transmittal received;

WHEREAS, upon knowledge of the aforementioned premises, 7th City Council deemed it necessary to pass a resolution appealing before the Sangguniang Panlalawigan the declaration as invalid Sorsogon City Ordinances previously submitted for review and instead the same be declared remanded to the Sangguniang Panlungsod for compliance purposes;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by the body, resolved as it is hereby resolve to appeal before the Sangguniang Panlalawigan the declaration as invalid Sorsogon City Ordinances previously submitted for review and instead the same be declared remanded to the Sangguniang Panlungsod for compliance purposes;


