**RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF PHOENIX SOUTHERN PETROLEUM CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION LOCATED AT MAGSAYSAY ROAD, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, the Sangguniang Panlungsod was in receipt of a letter from Mr. Patrick Estipona, OIC, Sales and Operation of Phoenix Southern Petroleum Corp., addressed to Hon. City Vice Mayor Mark Eric. C. Dioneda, dated September 10, 2020;

**WHEREAS**, Mr. Patrick Estipona, OIC, Sales and Operation of Phoenix Southern Petroleum Corp. through its letter is requesting for the approval of site development to build Phoenix Gasoline Station located at Magsaysay Road, Barangay Bibincahan, East District, Sorsogon City;

**WHEREAS**, the application letter was calendared during the September 22, 2020 regular session of the 7<sup>th</sup> City Council and was subsequently and jointly referred to Committee on Land Use, Urban Planning and Housing and to Committee on Transportation and Public Utilities and that on October 2, 2020, a joint committee hearing was conducted for the purpose;
