RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT WITH DEED OF DONATION RELATIVE TO THE ASSISTANCE (SURPLUS THEATER EQUIPMENT) OF THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS TO THE CITY GOVERNMENT OF SORSOGON IN THE OPERATIONALIZATION OF THE SORSOGON CULTURAL CENTER.

WHEREAS, the National Commission for Culture and the Arts (NCCA) has in its possession surplus theatre equipment and has expressed its interest of donating the same to the city government of Sorsogon with the end view of utilizing the same in the furtherance of the NCCA's mandate to express creative expressions;

WHEREAS, the City Government is willing to accept the donation and adhere to the stipulations therein set forth in the spirit of cooperation and support to the development of local artistic expressions;

WHEREAS, considering the need to expeditiously process the donation through the immediate submission of the Memorandum of Agreement (MOA) with the Deed of Donation (DOD) to the National Commission for Culture and the Arts (NCCA), the City Mayor has affixed her signature to the said document in order to facilitate the speedy transfer of the theatre equipment;

NOW THEREFORE, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Fernando David H. Duran, III**, the body, resolved as it is hereby resolve to ratify the Memorandum of Agreement with Deed of Donation relative to the assistance (surplus theatre equipment) of the National Commission for Culture and the Arts to the City Government of Sorsogon in the operationalization of the Sorsogon Cultural Center.


