**RESOLUTION RESPECTFULLY REQUESTING ATTY. ERIC B. DISTOR, NBI DIRECTOR TO  
PUT UP AND ESTABLISH A SATELLITE AND EXTENSION SERVICE CENTER FOR THE  
ISSUANCE OF NBI CLEARANCE FOR SORSOGON CITY**

**WHEREAS**, there are numerous requests from the residents of Sorsogon City particularly from far flung barangays to establish a satellite and extension service center in the city so that they can conveniently and expeditiously avail the services of the NBI in the issuance of NBI Clearance;

**WHEREAS**, majority of the residents in the City of Sorsogon and of the whole Province of Sorsogon, have no extra economic or financial subsistence to afford additional money, time and effort in their application for the issuance of NBI Clearance in Legaspi City, especially during this time of Pandemic;

**WHEREAS**, Sorsogon City is comprised of 64 barangays and the Province of Sorsogon is comprised of 14 municipalities and a city;

**WHEREAS**, the establishment of an NBI satellite and extension service center in Sorsogon City could also extend its services to the nearby province of Samar, when the health situation due to Covid 19 returns back to normal;

**WHEREAS**, the City Government expressed its noble intention to provide the bureau an office space necessary for the aforesaid request;

**WHEREAS**, foregoing premises considered, it is deemed just, proper and necessary to put up and establish a satellite and extension service center for the issuance of NBI Clearance in the city of Sorsogon, hence, this request;

**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

**NOW THEREFORE**, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to respectfully request Atty. Eric B. Distor, NBI Director to put up and establish a satellite and extension service center for the issuance of NBI Clearance for Sorsogon City.
