RESOLUTION RESPECTFULLY URGING THE OFFICE OF THE CITY LEGAL OFFICE, CITY ASSESSOR'S OFFICE AND OFFICE OF THE CITY TREASURER TO COME UP WITH THE PRODUCTION OF THE OWNER'S DUPLICATE COPY OF TCT/T 21242, PART OF THE PARCELS OF LAND DONATED BY FIL HOMES DEVELOPMENT CORPORATION TO THE THEN MUNICIPALITY OF SORSOGON

WHEREAS, the measure was re-discussed during the October 6, 2020 regular session as item 9.12 in its calendar of business;

WHEREAS, the City Government has an standing claim of ownership over the aforesaid property;

WHEREAS, the document as herein described is necessary to resolve questions of ownership with finality so that the City Government could already introduce development on the property in issue;

WHEREAS, it is most respectfully requesting the Office of the City Legal Office, City Assessor's Office and Office of the City Treasurer to initiate legal and/or administrative action to recover and/or reproduce the Owner's Duplicate Copy of TCT/T- 21242;

NOW THEREFORE, on incidental motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Fernando David H. Duran III**, resolved as it is hereby resolve to respectfully urge the City Legal Office, City Assessor's Office and Office of the City Treasurer to come up with the production of the Owner's Duplicate Copy of TCT/T- 21242, part of the parcels of land donated by Fil Homes Development Corporation to the then municipality of Sorsogon.
