RESOLUTION ENJOINING ALL BEAST OF BURDEN OWNERS, DOMESTICATED AND PET ANIMAL OWNERS TO TAKE FULL CARE AND ATTENTION OF THEIR LIVESTOCK AND PET ANIMALS TO AVOID ROAD ACCIDENTS

**WHEREAS**, just recently, road accidents involved beast of burden animals resulting to damage to property and instant death of farm animals roaming along the national highway;

**WHEREAS,** other road accidents recorded also involves pet animals such as dogs and the like also resulting to damage to property and even untimely death of motorcycle users;

WHEREAS, at present, Sorsogon City has an existing ordinance in relation to "Responsible Pet Ownership" wherein enforcement of the same should be closely monitored and implemented in order to avoid road mishaps and accidents thereby protecting the interests of our fellow road users;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution enjoining all beast of burden owners, domesticated and pet animal owners to take full care and attention of their livestock and pet animals to avoid road accidents;

**NOW THEREFORE**, on motion of **Hon. Erwin J. Duana** duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to enjoin all beast of burden owners, domesticated and pet animal owners to take full care and attention of their livestock and pet animals to avoid road accidents;
