RESOLUTION ADOPTING CDRRMC RESOLUTION NO. 04, SERIES OF 2020 FOR THE REPROGRAMMING OF TRUST FUND DRRM SAVINGS COVERING THE YEARS 2015, 2016 AND 2018 WITH THE TOTAL AMOUNT OF FIVE MILLION (P 5,000,000.00) PESOS TO BE TRANSFERRED TO SUPPORT DISASTER RISK REDUCTION WORK OF OTHER LGUs UNDER STATE OF CALAMITY-TYPHOON ROLLY

WHEREAS, typhoon Rolly (international name: Goni), the strongest typhoon to hit the Philippines this year landed in the Bicol region destroying thousands of homes and killed at least 20 people in the region;

WHEREAS, In the early morning of 1 November 2020, Super Typhoon Rolly made its first landfall in Bato, Catanduanes with catastrophic winds of up to 280 km/h and

torrential rainfall causing significant flooding, loss of lives and damage to power lines, communication facilities and other infrastructures;

WHEREAS, most of the fatalities were either swept away or buried by volcanic ash and mud that thundered down the slopes of Mount Mayon as torrential rain and monster winds whipped the active volcano in Albay;

WHEREAS, Over 300 houses were buried under volcanic rock and mud flows from the Bicol Region's Mayon Volcano, storm surges hit some coastal towns, while rivers overflowed and dykes were destroyed and submerging several villages;

WHEREAS, with COVID-19, the most vulnerable displaced populations have become even more vulnerable;

WHEREAS, Section 6.4 of the same JMC states that "the unexpended LDRRMF shall accrue to special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction and Management Council (LDRRMC) for the next five (5) years";

WHEREAS, with the Trust Fund DRRM Savings covering the years 2015 (P 2,311,145.49), 2016 (P 37,664.86) and 2018 (P 2,651,189.65) with the total amount of Five Million (P 5,000,000.00) Pesos, the city government of Sorsogon through the CDRRMC reprogram the same and transferred the same amount to Support Disaster Risk Reduction Work of other LGUs under State of Calamity, purposely to extend financial assistance to our neighboring LGUs in the Bicol Region that severely devastated by Typhoon Rolly;

WHEREAS, extending our deep sympathy, the amount of Five Million (P 5,000,000.00) Pesos is hereby extended by the Local Government of Sorsogon City to our neighboring LGUs as an assistance for their recovery efforts;

NOW THEREFORE, on motion of **Hon. Nestor J. Badon**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to adopt CDRRMC Resolution No. 04, Series of 2020 for the reprogramming of Trust Fund DRRM Savings covering the years 2015, 2016 and 2018 with the total amount of Five Million (P 5,000,000.00) Pesos to be transferred to Support Disaster Risk Reduction Work of other LGUs under State of Calamity-Typhoon Rolly.
