**WHEREAS**, the Sangguniang Panlungsod was in receipt of Transmittal No. 09, Series of 2021, attached therewith is a draft of Terms of Reference relative to the proposed Web Hosting Services of Sorsogon City Website by the Grapikom Solutions Inc. a private company with expertise in the said field;
