RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A DEED OF CONDITIONAL DONATION IN FAVOR OF THE PHILIPPINE ARMY FOR THE CONSTRUCTION AND OPERATION OF CAMP PABELANE INVOLVING A PARCEL OF LAND CONSISTING OF AN AREA 5,000 SQUARE METERS LOCATED AT SITIO MADAN-AN, BRGY. BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, Camp Pabelane is the site for army reservists tasked to implement community support programs aimed at developing camaraderie between the armed forces and the civilian community;

WHEREAS, in the previous years, Camp Pabelane housed army reservists in its previous site at Brgy. Balogo, East District, Sorsogon City, however, the said area shall now be used for a different purpose which brought forth the transfer of the camp to a more suitable area for their operation;

WHEREAS, a five thousand (5,000) square meter area at Sitio Madan-an, Brgy. Bibincahan, East District, Sorsogon City was identified for the construction of new building for Camp Pabelane;

WHEREAS, the said parcel of land is owned and possessed by the city government and shall be donated to the Philippine Army for the aforesaid purpose;

NOW THEREFORE, on motion of Hon. Nestor J. Baldon duly seconded by Hon. Franco Eric O. Ravanilla, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Deed of Conditional Donation in favor of the Philippine Army for the construction and operation of Camp Pabelane involving a parcel of land consisting of an area 5,000 square meters located at Sitio Madan-an, Brgy. Bibincahan, East District, Sorsogon City.
